



THE CARNEGIE LIBRARY
has been much in the public eye
recently, and details of the
structure have been described at
some length by both Ken Berg and
Betty Nelson, writing in the Free
Press. Mrs. Nelson's interest has
been focussed on the interior of
the building, which is most likely
to be greatly altered, if the library is sold to private investors.
Ken Berg has called attention to
the elements of local craftsmanship
and materials in the details of
the exterior.

With the thought of anticipating and partially forestalling the total loss of these pieces of our past (Remember the Saulpaugh!), I hastily betook myself to the spot on February 25, when the building was open for a meeting of the Arts Council, to see what photographs I could get. An adequate photographic documentation of the interior is, alas, far beyond my limited equipment and skill as a photographer. I did succeed in recording two bits of the inside, the fireplace which Mrs. Nelson has described, and the marble tablet on the wall of the central rotunda area, with its inscription which declares the building to be a monument to the generosity of Andrew Carnegie. Ken Berg has called attention to the exterior stonework of the building, which was quarried in Mankato. T. R. Coughlan had the contract. Mr. Harold Appel, who supplied Ken with a 1902 photograph of the stonecutters crew, believes that his grandfather, Henry Feldbusch, did the lettering of the great stone lintel. Feldbusch very likely produced another special piece which is less evident to the casual observer - the cornerstone at the righthand side of the facade.

The stone bears the representation of an open book and the Latin inscription recalls the Biblical account of the Creation in the Book of Genesis (I, 3.): (And God said) "Let there be light, and there was light."

The laying of the cornerstone took place on July 2, 1902. The event is described at length in the Free Press of that time. The ceremony was conducted by the Mankato Masonic Lodge No. 12, A.F. & A.M.; and doubtless for this reason, the contents of the stone (listed in the newspaper account) are mostly items having to do with that organization! The other items mentioned are a history of the public library, a resolution of the library board, copies of the souvenir editions (50th anniversary of the city) of Mankato newspapers, and a "picture of the execution of the Indians"! (Presumably the lithograph published by J. C. Wise.)


Dear Marcia:



This past week the architects made their final inspection of the exterior restoration work at the Hubbard House and pronounced it a job well done. There was enough grant money left over to pay for replacement of rotted beams and stablilization of the side porch off the kitchen. Progress!

Margaret Buehler is Museum Director there. We became acquainted at an AASIH workshop.

Education: School Programs and the Museum is the title of a correspondence course your director is taking from the American Association for State and Local History. Since many historical societies are unable to afford to send personnel to their workshops, AASLH is offering correspondence courses on a variety of subjects pertaining to museum operations. So far this course has provided me with a lot of good information, and a chance to learn more about coordinating museum and school programs.

Our newest artifact is a gift from the City of Mankato Street Department - a handhewn stone curb, corner section, complete with manhole cover. We placed it at the rear corner of the Carriage House; and it makes a very appropriate addition to Palmer Place, which has replicas of early Mankato street lights. Thanks to Foreman Don Paegel and city street crews, for thinking of us instead of hauling it to the dump!

Is anyone missing a spoon? One was left behind after the Christmas potluck supper at the Museum. Please claim it, or we'll put it in the rummage sale.



PHOTOGRAPH (ca. 1910) OF A GROUP OF BLUE EARTH COUNTY OFFICIALS



This photograph, taken in the Commissioners' Room of the Blue Earth County Courthouse, presumably shows eight county officials, one of whom is William Schultz, father of the donor, Mrs. Ward Gray (née Mary Schultz), of Minnetonka, Minnesota. Mrs. Gray believes that the picture was taken about 1910. She identified the group as the Board of Commissioners. However, this cannot include all of the men in the picture, as the Board had only five members. Mrs. Ward recalled the man seated at the extreme left as Ed Weaver, who was county auditor for many years, but never served as commissioner. On the back of the photograph Mrs. Gray wrote earlier: "Wm Schultz seated L. side as one faces picture". However, in a phone conversation, she said that her father had a moustache, and the man with the moustache is seated on the right, as one faces the picture!


I have not yet been able to call on Mrs. Gray with the picture in hand, to ask for clarification. Extensive search through our photo files, books and newspapers has so far yielded nothing but guesses.

Can any of our readers help us out?

Possibilities: William Schultz was 4th
District Commissioner 1903 - 1910. His
colleagues in 1909 - 1910 were Robert
Madigan of Eagle Lake, 1st District; Delos
P. Young, 2nd District; Alec Hansen, Lake
Crystal, 3rd District; and Charles E.
Jones, Mapleton, 5th District.

Of other county officers in those years, no one in the picture resembles the two judges, A. R. Pfau, Sr., District Court, or William F. Hughes, Judge of Probate. The same is true for Thomas Hart, Treasurer. The man seated second from the right looks a bit like Ben Bangerter, Register of Deeds; and the man at the extreme right bears some resemblance to Stephen Thorne, Clerk of Court. However, maybe this is William Schultz. We haven't yet found any photographs for comparison of John Donahue, Sheriff; Walter Plymat, County Attorney; Wm. B. Davies, Court Reporter; E. R. Kennedy, County Coroner; O. O. Ulvin, Superintendent of Schools; or Walter F. Brooks, County Surveyor.

If you have any guesses, please call Jeanne Kress at the Museum. We'd like to identify everyone in the picture, so as to furnish Milt Owens, our County Auditor, with correct information. Then he can label an enlargement for the Courthouse!



ACTIVITIES AROUND THE COUNTY

Members of the TRAVERSE DES SIOUX GENEALOGICAL SOCIETY are engaged in several on-going projects which will be of great value in preserving information on the history of the county. Efforts are concentrated on recording private cemeteries (family plots and single graves) throughout the county. Dean Pettis had taken pictures and transcribed inscriptions from the Stratton family burial plot near Good Thunder. He has also investigated the church site and cemetery at Caroline Station. Microfilming of cemetery and church records is also under way. The records of Minneopa and Pilgrim's Rest cemeteries have already been microfilmed, as well as an early record book from Glenwood Cemetery. Margaret Schreyer is presently engaged in microfilming the records of the Eagle Lake Methodist Church.

In addition to these activities, the society has regular meetings which combine a program and related work on individual. members' investigations. At a meeting on March 4, the speaker was Jenny Robinson of Mankato, Vice President General, National Society DAR, who talked on how the DAR relates to genealogical work. The subject of the evening's work session was census records. The next meeting will be April 1st, with a program by Betty Goodrich on how to organize genealogical research data.

The society is very anxious to record private burial sites in the county, and would appreciate information about such sites. Please contact any member of the Genealogical Society, or call the Museum.

Dick Fasnacht informs us that "Doc" Sheppard and other residents of MADISON LAKE are working to organize a historical society there. The group had originally sought to have the old fire station as a historical center, but found this not feasible, because of the poor condition of the building. Plans now are to have space in the new Community Center and Fire Station.

Architectural plans are for an office and space for both wall and case displays in the vestibule and corridor areas. A permanent wall display of historical photographs (enlarged reproductions) from the collection of Charles Hoehn is planned for the main community room.

The LAKE CRYSTAL AREA HISTORICAL SOCIETY, having sold its property on the edge of the city to Blue Earth County for the Highway Department, is looking for a permanent and more centrally located home for its collections and activities.

Alice Hollingsworth's slide-tape program on the history of Lake Crystal is a project which has developed from work done for the city's centennial celebration in 1970. The society has published the script of the program as a separate pamphlet, entitled "Beginnings: Early History of Lake Crystal". (22 pp., price \$1.00). It traces the history of the town from its very start down to 1900. The slide-tape program, which takes approximately one hour and fifteen minutes, consists of some 80 slides, mostly photographs, supplemented by pictures which illustrate parts of the narrative for which no photographs exist. These illustraions are the work of Sue Crane, Myrna Thomas and Edith Sutherland. Mrs. Sutherland is now working on additional illustrations for a second program, which will cover the history of the community from 1900 to the present.

Society officers who continue to serve are James Zwickey, President; Mrs. Lester Williams, Vice-president; and Mrs. Alfred Lee, Secretary-Treasurer.

PUTTING THINGS TOGETHER:

AN OLD HOUSE AND A NEW MUSEUM EXHIBIT

At the Museum we are continually concerned with fitting the things in our collection into exhibits that show our past in a meaningful and (we hope) interesting way. A case in point is a new display of objects related to "common school" education in Blue Earth County. It is located in the Hubbard House basement hall, close to our 1880's schoolroom, and includes a number of items which have been in the Museum for a long time, but which, as far as we know, have never been on view, to show our visitors, particularly those from our schools, what school was like a hundred years ago.

Accustomed to typewriters and xerox copying machines, today's young people are intrigued by the exercise and copy books used to teach penmanship, and by the "Handwriting Helper", a patented device designed to make the young penman hold his hand and pen in a certain position. They are surprised at the three-dimensional effect produced when they look at double photographs through a stereoscope. Also in the display are books from the Minnesota Textbook Series, officially authorized in the 1880's, to insure that country schools would have some uniformity of instruction, based on books written by authors recognized as competent in their subjects. There are also photographs of Mankato's first four elementary schools and of schools and classes in other places in the county.

The item that links this exhibit with the charming old house at 618 Byron Street is the teacher's certificate issued to Horace B. Perrin in 1865. It was discovered in a bundle of old papers in the cellar of the house, which Perrin owned and lived in from 1894, when he came to Mankato, until his death in 1933. (After him, his daughter Alice, Mrs. Josiah A. Baker, owned and occupied the house until 1977.) The certificate is one of some 34 items found by William Krueger, the present owner, who gave them to the Historical Society last year. Most of them are too fragile to be exhibited, but they provide interesting details of the history of the Perrin family, whose members apparently were quite important in the Amboy area in the earliest period of its history.

William F. Perrin came to Blue Earth County from Vermont, bringing his family with him, and took up land in Pleasant

PUTTING THINGS TOGETHER (Cont'd.)

Mound Township in 1863. There he farmed, was a town supervisor for 20 years, and also served as town clerk, until he moved into Amboy in 1890, to live with his son Willis. He was a Blue Earth County commissioner from 1872 to 1876, and served a term in the State Legislature in 1879. The family kept some of their farm property in Pleasant Mound Township until the mid-1920's, but seems to have resided in Amboy, where William died in 1902.

His other son, Horace, had a varied career. In 1864, at the age of twenty-one, he enlisted in the Eleventh Regiment of Minnesota Infantry, the last Civil War unit to be recruited in the state. A certificate of his promotion to corporal in Company "C" of the regiment, and a personal memorandum book, in which he kept track of some of his activities while in service, are among the papers found in the house.

When he returned home to Blue Earth County, he taught school in Sterling Township, but shortly moved into the village of Amboy and went into business as a dealer in farm implements. He apparently was the first teacher in the Amboy school, also the first chairman (mayor?) of the village council, and was one of the founders of the IOOF Lodge in Amboy. Like his father, Horace was elected to a term in the State Legislature in 1889.

He left Amboy in 1892, to spend two years in Sioux Falls, S.D., but returned to Minnesota in 1894 and settled in Mankato. His first venture in business was as a partner in the long-established carriage-making firm of H. P. Jensen. About 1905, he had a carriage business of his own, and shifted to automobiles about 1909, as an agent for Overland, Chalmers and also Ford vehicles. His showroom and garage were at 520 South Front Street.

At the same time he was an independent insurance dealer, and was very active in the organization of the Mankato Citizens Fire Association, serving as secretary-treasurer from its establishment in 1894. This association seems to have been the first mutual fire insurance company in Minnesota.

Insurance continued to be Perrin's principal interest until his retirement in 1925, at the age of eighty-two. The automobile agency, managed by his son Harry, went out of existence about this time, it would seem; and Harry moved to California. Horace's two daughters, Alice and Minnie, taught school in Mankato and Kasota respectively, until they married; and both lived out their lives in Mankato. So the name Perrin disappeared from the scene in Mankato, but the family house at 618 Byron Street remains, a well-preserved example of Mankato domestic architecture of the 1890's.
